Selangor Bar Coffee Morning was held at Sepang Court on 21-4-2025

We have meeting with “Ketua Pusat Kos” Tuan Ahmad Fuad Bin Othman after our observation that only one magistrate court handling all civil and criminal matters and raised concern on the need to have another magistrate.

1. **YBGK lawyer**

Pursuant to the request of the YBGK lawyers, we have discussed with the “Ketua Pusat Kos Mahkamah” to allow the YBGK lawyers to interview the OKT at the lock-up itself, in order to avoid interruption to court proceedings and to save time.

2. **Tout**

We also discussed complaints relating to touting on the complaint received by us.

We suggested that a form "Borang Kebenaran Berurusan Dengan OKT" be prepared as a measure to prevent touting which is practice in Sepang Court.

The Court had informed us that they will discuss with the Sepang court about it.

We have also met the Registrar of Klang Court Puan Farisha to discuss on the issue of touting and we have inform that she will discuss with the registrar at Shah Alam Court .

1.
